
Once we made it to a place far away from the church, we listened as our other friend told the same story.

Students suggest alternatives for inadequate parking

Enrollments for community colleges are on the rise. Statistics have shown a steady increase in the number of students wishing to complete some tertiary education; a trend that looks set to continue.

The DMACC Boone campus itself has record numbers this semester. While this is great news for the community and educators alike, there are some drawbacks to having such numbers utilizing such a small campus as Boone.

As well as the Courter Center being filled to capacity, and the computer labs always being full, another major problem for students is the current parking situation. Being a commuter school, the vast majority of students at Boone drive to class everyday, making it difficult to find enough parking spaces for the newest increase of students. "Parking is a legiti-

mate concern," says Aaron Coats, freshman at Boone DMACC. "As weather gets bad and more students come every semester, the problem is only going to get worse before it gets better."

Leah Reeves, sophomore, agrees; "As long as you come when are classes are changing, you are alright, but if you come early, like in the middle of another class, it is impossible to find a parking space."

One possible solution is to expand the parking lot, a rather costly enterprise that would force Boone to lose some valuable lawn space. Cost could be kept down by utilizing the talents of DMACC students studying surveying and design; a potential work-study or independent study program. This would be the more desirable solution, yet budget constraints may prevail.

A more temporary, less expensive solution would be to restructure and repaint the lot in the northwest corner of the building. This lot is closest to the bulk of the classrooms and a highly inefficient use of space. It currently allows for only a very small number of vehicles to park there. According to the current dimensions of the space, if the traffic islands were removed and the spaces were repainted to face perpendicular to how they are presently aligned, up to 36 spaces would become available instead of the six handicap and the 24 general spaces now available.

There seem to be several solutions that DMACC could

embrace, budget and space allowing. Student Jun Young has suggested that a parking ramp could be the answer as the traffic increases with each semester.

As enrollments multiply, the facilities of this institution must grow to meet the needs of its students. Providing adequate

parking is just one of the many standards that must be maintained by DMACC. Since many of Boone's students lead very busy lives between classes, that sufficient space be provided to them for their vehicles

Stop in the name of the law-Speed Enforcement 101

Police officers have been chasing speeding cars ever since Walter Arnold secured his place in history as the first automobile driver to receive a speeding ticket in 1896. Although the basic Cop vs. Driver formula remains the same, the technology is much different on how speeds are determined.

With increased enforcement on the roads, the chances of getting stopped by "Smokey Bear" and ticketed for "fudging" the limit increases.

But how do they do it?


The most widely used method for speed enforcement is the most familiar, police radar. Police radar works using what is known as Doppler Shift: radar waves are sent out, reflected back off of a moving object (car, truck, motorcycle), which changes the frequency of the waves being reflected back. The speed of the object determines the reflected frequency and the electronics inside of a radar gun unit convert that change into the speed of the object. Most radar guns are mounted on the dashboard or in the rear window but they may also be hand-held.

There are three bands of radar used in the United States:

X band, which is the oldest band (introduced in the mid 1950's), has all but disappeared from most police agencies, except for a few states like Iowa.

K band introduced around 1976 as a way to thwart the first generation of radar

detectors that were introduced which only picked up X band.

Ka band, introduced in 1989, first as rarely used automatic "photoradar" units but then slowly were developed into super accurate hand-held and mobile Ka radar units.

Radar guns can either be left on continuously or be used in an "instant-on" mode, where the radar isn't activated until a target vehicle is selected.

In the mid 1990's a new speed enforcement tool was introduced, the laser gun, or Lidar as it is more commonly referred to. Lidar is more accurate than radar because it uses a sight, much like a sharpshooter, that helps the officer better aim the gun at the intended target and shoots a narrow invisible laser beam at the target vehicle. Lidar has to be hand-held and therefore can only be used as an "instant-on" unit.

But there are other ways "Smokey" can catch "The Bandit."

VASCAR, which stands for Visual Average Speed Computer and Recorder is a device that an officer records the time it takes a vehicle to cross two pre-determined reference points, usually an eighth

of a mile apart.. Those white rectangles painted on the middle of the traffic lanes on the highways in Iowa are VASCAR reference points. Many states, including Iowa, often use aircraft when using VASCAR

Patrol cars have speedometers that are "Certified Calibrated", meaning they are dead on, 65 mph is 65 mph, not the plus or minus a few mph the average car has on it's speedometer reading. That way an officer can pace a vehicle from a distance, note the speed, and then pull it over. This is most often used on crowded city freeways where multiple targets would make using radar rather difficult.

Police can catch speeders by way of

citizen complaints. Testing the top speed of that new Mustang Cobra on I-35 might get you in a lot of trouble, due to a concerned citizen with a cell phone.

While any number of countermeasures, such as a radar/laser detectors, CB radios, mobile scanners, etc., can be employed. The best defense against a speeding ticket is a sharp eye.

Watch out for possible hiding places and police vehicles on the move and common sense, like not doing 90 mph coming down that hill into Boone or speeding down the road leading into Boone Campus.

Drinking problems in people who do not have all the characteristics of alcoholism are often referred to as "problem drinkers" or "alcohol abusers." These individuals engage in excessive drinking that results in health or social problems.

Alcoholism and alcohol abuse cause major social, economic, and public health problems. Each year, more than 100,000 people die of alcohol-related causes and of those 100,000 more than 2,000 are between the ages of 15 and 20.

One DMACC student who wishes to remain anonymous said, "I don't think I have a drinking problem. I go out on the weekends and sometimes during the week. I just do it to have fun." Yet seven of the signs below applied to her.

Tyler Ehlert, another DMACC student, said, "I'm not an alcoholic. Getting drunk is just fun. Beer is your best friend if you drink enough of it." All but two of the signs below applied to Ehlert.

According to the National Council of Alcoholism and Drug Dependence, more than 13 million Americans abuse alcohol. Most people deny, laugh about, and avoid the issue of problem drinking.

Here are some signs of problem drinking according to various internet sites:

- *Getting in trouble as a result of drinking.
- *Drinking to escape worries or problems.
- *Having to drink more and more to get the "desired effect," or drinking more than planned
- *Not remembering parts of what happened the night before.
 - *Missing class or work due to drinking.
 - *Drinking solely to get drunk.
- *Unexplained anxiety, sleeping trouble, depression, or feelings of alienation or isolation.
 - *Getting drunk frequently.
- *Focusing all social situations around alcohol.

If more than two or three signs applied to you, it may mean that alcohol has almost certainly become- or is becoming-a serious problem. For more information or help contact:

Over 30,000 lowa women battered daily

Every 9 seconds a woman is battered in the United States, according to the Family Violence Prevention Fund.

The Office of the Surgeon General reported domestic violence as being one of the foremost causes of serious injury to women ages 15-44. On an even more serious note, from 1995 to the present, 97 Iowans were killed due to domestic violence; 61 women, 11 men, and 25 bystanders (someone else present, but not participating).

A great number of children are also witnessing the abuse. The National Woman Abuse Prevention Project found that an estimated minimum of 3.3 million children witness domestic violence each year. Children in these situations see home as scary, not as the safe place they maybe once knew.

Victims of domestic violence usually experience negative treatment from their partners either physically, verbally, or even both. The abuser has many ways of gaining a sense of power and control. (See figure)

Maggie Stone, of the Displaced Homemakers Center said, "Nobody deserves to be in a situation like that. Many people are afraid and are made to feel like it's their fault, but it's not."

An estimated 30,000 Iowa women are battered every day, according to the Iowa Attorney General's Office. Victims of domestic abuse need to know that there are shelters around to go to for support.

The Assault Care Center Extending Shelter and Support (ACCESS) in Ames is local place to go for help. ACCESS is funded by Story and Boone counties, and offers 24-hour confidential help for domestic violence and sexual assault. The crisis number is 515-232-2303 or toll free 1-800-203-3488.

Ann Greenfield, Director at ACCESS said, "Although the number of people killed is horrific, we need to look at all cases. There are women living in danger every day, and by increasing services to people we can hopefully decrease the

number of murders."

Coheed and Cambria, an East Coast-spawned four-piece band with a twist recently released their freshmen album on Equal Vision Records. 

A recent movie that has just been released on DVD is "Frailty". This



thought we'd put that pool table to use by playing a friendly game of cutthroat.



Bears end regular season in fashion



With focus now turned solely to the playoffs, the DMACC Bears volleyball team has their sights on Toledo, Ohio. Not your typical vacation destination, Toledo is the sight of this year's NJCAA tournament.

First however, the Bears must get through their regional bracket, where they have the #2 seed. Kirkwood, who the Bears beat two weeks ago in a thriller, received the #1 seed.

Working in the team's favor is the confidence going into the postseason. Already having victories these past two weeks over conference heavyweights Kirkwood and Iowa Central, the #3 seed in the Bear's bracket, the momentum gained will be pivotal in their quest to Toledo. Those two wins were the gems as the Bears closed the season, winning 12 out of 13. The loss, however, may have been the most important of the 13 games.

Sports are a game of emotions, and a team performs best when on an even-keel. The loss to Indian Hills ultimately will keep the Bears grounded, and hungry.

Coach Slight agrees. "Winning all the time and facing no adversity is easy...a sign of a good team is the ability to bounce back from a loss and pounce on teams again," she said. This is exactly what the Bears did, as they won their final

Coach Slight was also quick to point out that the loss to Indian Hills, if nothing else, was nothing more than a meltdown, and if her team can maintain a high level of performance, they could have beaten the Warriors. "Had we just done things we usually do well a little bit better, I think the outcome would have been a lot different," she said.

The win against lowa Central to close the season was huge for the Bears. Not so much for the element of revenge, but because it gives them the second seed in the regionals. If they would have lost to ICCC, they would have been the third seed, said Coach Slight. "As a second seed, you play, you're off, you play, you're off, and so on. As a third seed, you play back to back, then you're off."

In essence, it is a lot easier to get into a rhythm as a second seed than a 3rd, and the team will have fresh legs for every game in the tournament. They can take comfort in the fact that they won't have to face Kirkwood until the championship, assuming both teams make it that far. That leaves the Bears as the favorite to win their side, or Pool B, of the bracket.

As favorites, however, Coach Slight acknowledged every team will be gunning for them. "We can't overlook any team when it comes to regionals," she said. "Iowa Central, Iowa Lakes, and Southwestern have all beaten top ten ranked teams this year, so when it comes to the 4th and 5th seeds, it can be a little tricky."

Although the Bears will get every team's best shot, Coach Slight exudes confidence in her team's ability to get to Toledo, knowing if they take care of business, everything will fall into place.


