REVIEW OF SEPTEMBER
8, 1981 ELECTION
RESULTS

Board Secretary Irv Steinberg reported that the Polk County Board of Supervisors had canvassed the results of the September 8, 1981 school election involving election for a Director for Des Moines Area Community College Districts No. 2, 6 and 9, and that the Abstract of Election, a copy of which is attached hereto (Attachment #1) and made a part of these minutes, indicates the following election results:

Director District #2 -- Raymond Clark -- 3,417 votes
Director District #6 -- Eldon Leonard -- 2,964 votes
Director District #9 -- DeVere O. Bendixen -- 1,632 votes
