"We, the table team, representing the Des Moines Area Community College Board of Directors, having received instructions and parameters from the Board, entered into negotiations with the table team of the Des Moines Area Community College Higher Education Association. The table teams have reached agreement within the guidelines given to us by the Board and both chief negotiators have signed the tentative agreement. The tentative agreement has been ratified by the Association and the terms and conditions of the agreement made public for the requisite period of time.

We, the table team, urge wholeheartedly the ratification of the agreement by the Board. The table team wishes to express its appreciation for the cooperative attitude of all involved-the Board; Administration, Association, and Faculty. By approaching collective bargaining in a spirit of good faith exchange we have all made the process work, and work well to the advantage of everyone involved.

The cooperative attitude shown by all concerned has enabled Des Moines Area Community College to avoid the pitfalls encountered by others in this first year of public employees collective bargaining and has established a positive base upon which to build productive employer-employee relationships. Such an ongoing positive relationship will allow Des Moines Area Community College to reach its primary goal, which is to offer the best in comprehensive community college education. To this end we highly recommend ratification of this agreement by the Board.

It was moved by M. Campbell, seconded by D. Rowen, that the tentative agreement, previously signed by chief negotiators for both parties involved, a copy which is attached hereto and made a part of these minutes, which established salaries and fringe benefits for the 1976-77 school year, be ratified.

Director C. Galvin gave a report on his inquiry in Carroll, Iowa in reference to the sale of the student constructed house and the purchase of additional lots for such future construction.

It was his recommendation that an appraisal be obtained from a Carroll Savings and Loan Association on the value of the student constructed house prior to establishing a minimum bid on the sale of this house. The administrative staff was so directed to follow this recommendation.

In regard to taking action on the previously agreed purchase of three additional lots in Carroll, the administrative staff were advised to proceed, subject to verification that no restrictions are in effect on the property which would hamper the sale of house when completed. Director Galvin noted that some restrictions were thought to be possible.


VIEW AND
