CALL TO DMACC Board Chairman, Eldon Leonard, called the meeting to
ORDER order at 4:00 p.m. Both the Des Moines Area Community College
and Heartland Education Agency had representation at the meeting.

HANDICAPPED D. Hiner, E. O'Leary and D. Tucker presented information on
IN education for the handicapped persons in Area XI between the
EDUCATION ages 18 and 21. It was noted that there are 3,873 handicapped
secondary school (grades 7-12) age students in Area XI. There
are approximately 470 special education students ages 18-21 in
Area XI. The presenters indicated that a weighted tuition cost
from the local district that would cover the total cost of
instruction might provide the source of funding. The curric-
ulum needed by each would have to be developed; a specialized,
individually paced curriculum would probably be needed.
Heartland would provide some special resources and possibly
coordinate the total effort.

A next step may be to present the materials and data acquired
to date to the Heartland Advisory Committee. Based on recep-
tivity there, and a plan for the continued education of the
special students, a presentation could be considered for the
local superintendents in Merged Area XI.

Eldon Leonard and Ed Long indicated they would like the effort
to serve handicapped students continued and something accomplished.

MOBILE CEC Dennis Krehbiel gave a report of present status. Eldon Leonard
indicated that he may like to come back to Heartland to see if
they will increase their contribution. Discussion also needs
to be pursued regarding the operation of the total project by
Heartland.

ADJOURNMENT Meeting was adjourned at 4:55 p.m.
