

After the hearing the Board shall adopt the amendment as finally determined and their action shall be made a matter of record. Local budgets shall be amended by May 31 of the current fiscal year. For detailed information, see Chapter 24, Code of Iowa.

RECORD OF HEARING AND DETERMINATION ON THE AMENDMENT TO BUDGET

Be it remembered on this 26th day of May, 1992, the Board of Directors of Des Moines Area Comm College, Polk, et. al. County, Iowa, met in session for the purpose hearing on an amendment to the current operating budget adopted March 6, 1991. There was present a quorum as

required by law.
